In accordance with Article 3, Section 3 of the bylaws for The Estates of Tour 18 Homeowner Association, Inc., you are hereby given notice of and requested to attend the 2024 Annual Homeowners Meeting. The Annual Homeowners Meeting is scheduled for Thursday, November 20th, 2025, at 6:30p.m. Sign in will begin at 5:45 p.m. The meeting will be held at 8718 Amen Corner, the Golf Course Clubhouse.

From 5:30 PM until 6:30 PM, there will be a Welcome Reception with heavy appetizers and cocktails. This will allow owners to meet their neighbors and discuss issues in the community.

From 7:00 PM until 9:00 PM, the Annual Meeting will be held.

The quorum required to hold a meeting is fifty-one percent (51%) of all owners. If the required quorum is not present or represented at the meeting, a subsequent meeting will be called at 6:35p.m. and the required quorum shall be 10% of all owners.
